Smith, et al,* 832 F. 2nd 451 (7th Cir 1987) *Whitt v. City of Rockford, Ill.,* 700 F. Supp. 391 (N.D. Ill. 1988), *Lindenmier v. City of Rockford,* et al. 508 N.E. 2d 1201 (2nd Dist. 1987). I also successfully defended two taxes enacted by the city pursuant to its home rule powers which were challenged after the city repealed home rule in 1982. see *Royal Liquor Mart v. City of Rockford,* 479 N.E. 2d 485, 88 Ill. Dec. 872 (2nd Dist. 1985) and *Midwest Petroleum Marketing Assn. v. City of Rockford,* 496 N.E. 2d 20, 99 Ill. Dec. 674 (2nd Dist. 1985). I also served as counsel to the City Council's Legislation Committee..

Judicial Clerkship. For the first year after I graduated from law school I served as one of two law clerks to the late Earl E. Veron, Federal District Judge for the Western District of Louisiana, Lake Charles, Louisiana. While in the service of Judge Veron, I authored two decisions which were adopted verbatim by the Judge and published in the Federal Supplement. See *Adams v. Gaudet* 515 F. Supp. 1086 (W.D. La. 1981) and *Louisiana Chemical Assn. v. Bingham*, 496 F. Supp. 1188 (W.D. La. 1980).
